**WEEK FOUR (4) CSEC/CAPE REVISION CLASSES; June 29, 2020 to July 3, 2020**

As a consequence of Hampton School's being a Boarding Institution, the Administration has had to – during the COVID-19 Pandemic - **strategically schedule** specific grades of students to attend on specific days and in specific weeks, the CSEC and CAPE Revision Classes. Therefore, for the period June 8, 2020 to June 26, 2020, a carefully balanced number of Day Girls and Boarders have been scheduled to be on the school compound each day.

Our total CSEC and CAPE cohort is 561 students, distributed across the 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, Lower 6<sup>th</sup> and Upper 6<sup>th</sup> Forms. Of that number, 155 are Boarders. We have carefully avoided scheduling classes for all Senior Grades **concurrently**; while, **correspondingly**, providing the usual Boarding Accommodation for our CSEC and CAPE students. This is in order to remain in strict adherence to the MOH COVID-19 Health and Safety Protocols as well as the MOE COVID-19 School Reopening Guidelines for Boarding Facilities; which have directly informed our planning and scheduling.

However, in response to Parental Appeals, Hampton School will host an additional week of CSEC and CAPE Review Classes; June 29, 2020 to July 3, 2020.

**PLEASE NOTE:** The **conditions which will apply to the week of June 29, 2020 to July 3, 2020 are:**

- CSEC Students will follow the timetable that they used during the week of June 15 to 19, 2020

- CAPE Students will follow the timetable that they will also use during the week of June 22 to 26, 2020.
- **BOARDING PRIORITY** for June 29, 2020 to July 3, 2020 **will be given to those students who live in the farthest parishes of the country; as, at this time, the school can Board ONLY A VERY LIMITED NUMBER OF STUDENTS**, in accordance with the Health and Safety Protocols of both the Ministry of Health and the Ministry of Education .

**This means that, although ALL SENIOR STUDENTS are expected to report in Week Four (4) for classes, MOST Senior Students (approximately 100) who usually Board, will need to travel daily in Week Four (4) of the Review Classes, which our parents have requested.**
